Dear Breeder,

Your mare will be visiting Overbury Stud for the 2010 covering season. Unless the stud is previously advised, routine gynaecological examinations and treatments will be carried out on your mare by Bourton Vale Equine Clinic. This may include some or all of the following, **where the veterinary surgeon considers necessary:**

- Manual/ultrasound examination of the ovaries and uterus pre and post covering.
- Endometrial swab/smears.
- Clitoral swabs.
- Antibiotic uterine irrigation.
- Caslick operation.
- Oxytocin, Receptal and Chorulon injections.
- Regumate hormone supplement.
- Prostaglandin injections.
- Ultrasound examination for pregnancy at approximately 14 – 16 days, 28 days and 42 days post covering.
- Attention to foal.

Should an emergency arise necessitating treatment of the mare and/or foal, then this will be carried out in consultation with the stud manager. All efforts will be made to seek prior owner approval, but we reserve the right to carry out whatever procedures/treatment is deemed proper under the conditions presented. The welfare of the animal will be paramount.

Due to new credit control policies as a result of bad debtors, it has now become necessary for the clinic to insist on credit/debit card details unless you have a prior arrangement with the accounts department. Credit/debit card payment will only be debited from your account on the 21st of the month (post invoice). This will enable clients to scrutinise their accounts and to raise any queries they may have. Once these queries have been resolved and only then will the full amount will be debited. If you wish to pay by cheque, BACs or cash the payment must be received by this date. Details are confidential and will not be passed on to any third party.
