**CHECKLIST - BEFORE YOUR MARE ARRIVES AT THE STUD OR IS BOOKED IN FOR COVERING, PLEASE MAKE SURE WE HAVE RECEIVED:**

**For Mares which have not been outside the UK and Ireland within the last 12 months:**

- Signed Nomination Agreement
- Completed & Signed Details of Mare Form.
- Negative CEM Clitoral Swab certificate taken after 1<sup>st</sup> January 2025
- Negative EVA certificate taken after 1<sup>st</sup> January 2025
- Negative EVA certificate taken within 30 days of covering  Subsequent EVA taken within 30 days of covering
- Negative EIA (Coggins) Certificate taken after 1<sup>st</sup> January 2025
- Negative CEM Endometrial (Cervical) Swab certificate taken during current oestrus period (*“Walk-in” mares only – boarding mares will be tested at the stud before covering*)
- Signed Freedom from Infection Certificate
- FOR BOARDING MARES ONLY – NASOPHARYNGEAL SWAB FOR STRANGLES TESTED BY PCR AND TAKEN 7 DAYS BEFORE ARRIVAL AT OVERBURY OR CONDUIT STUD**
- IF BOARDING** - Signed and paid for Vet Scheme form (*only if taking up the scheme and not required for “walk-in” mares*) **Signed Vet Agreement form required for all mares boarding at Overbury Stud.**
- Passport (to arrive with the mare) showing updated influenza vaccination record (Equine influenza booster vaccination must be given within 6 months of arrival) ***WALK IN MARES A Photocopy of front page, identification page and influenza record is required and must be emailed to the stud before the mare arrives for covering.***

**For Mares which have been outside the UK & Ireland within the last 12 months you will need in addition to the above:**

- Negative EVA Certificate taken within 28 days of arrival in UK, plus 2<sup>nd</sup> test to be taken 14 days after arrival at UK stud (see overleaf) Subsequent EVA's may be required dated within 30 days of covering
- Negative EIA Certificate taken within 14 days of arrival in mainland Britain. 2<sup>nd</sup> test to be taken 14 days after arrival at UK stud (see over) and possible further EIA test to be taken within 21 days prior to covering. **Plus** foal certificate if arriving from Italy or Germany.
- Negative CEM Endometrial (Cervical) Swab certificate taken during current oestrus period (*“Walk-in” mares only – boarding mares will be tested at the stud before covering*)
- Negative Dourine Certificate dated within 28 days prior to arrival in this country for mares who have been in Italy since January 2012.
